Paxos is in no way responsible or liable for the administration of this Sweepstakes.	
Promotion Period	Begins April 19, 2024 at 12:00 p.m. EDT, and ends June 21, 2024, at 12:00 p.m. EDT (the “ Promotion Period ”)	
Eligibility	Age	Must be 18 or older. The Sweepstakes winner will be required to provide proof of name, age and address.
	Residency	Must be a US resident.
	SSN/TIN	Must have valid social security or tax identification number and proof of residency.
	Restricted Persons	Employees, agents, directors or officers of OANDA and Paxos, or any affiliate of OANDA or Paxos, including members of their immediate family (i.e., spouse, mother, father, in-laws, grandmother, grandfather, brother, sister, children and grandchildren and, even if unrelated, those living in the same household) are not eligible to participate in the Sweepstakes.
To Enter:	<p>Please complete the following steps during the applicable Promotion Period:</p> <ol style="list-style-type: none"> 1. Click on the OANDA Enter to Win Up To \$50,000 Worth of BTC Sweepstakes link provided by OANDA or a marketing partner of OANDA’s; 2. As prompted, enter requested contact information or confirm auto-populated information entry form; 3. Review the “Terms and Conditions” and click the “Accept” button; 4. Click the “Submit” button at the bottom of the entry form; 5. After the entry form has been submitted, you will be required to follow the steps to open both an OANDA FX trading account and an OANDA Crypto account (held by Paxos). <p>Upon completing the above steps 1-5 you will receive one entry into the Sweepstakes. Entrants who have an existing OANDA Crypto account (held by Paxos) do not need to complete step 5. Entrants with only an existing OANDA FX trading account do need to complete step 5 by opening an OANDA Crypto account (held by Paxos).</p> <p>NOTE: Digital assets in an OANDA Crypto account are held by Paxos and any trading activity in digital assets is executed through Paxos. There is no requirement to fund either the OANDA FX trading account or the OANDA Crypto account (held by Paxos), opening these accounts is solely to facilitate the transfer of BTC to the winners of the Sweepstakes.</p>	

Entry Limits	One entry per household during the Promotion Period. In the event of multiple entries being received from the same household only the first entry will be accepted.
Prize and Prize Value	<p>Three winners will be selected (as provided below) for one of the following three prize amounts awarded in BTC in a US Dollar-equivalent amount of: \$50,000, \$25,000 and \$10,000 respectively, as determined by OANDA as set forth below (the “Prize”).</p> <p>Approximate retail value of each Prize will be the US Dollar-equivalent amount as of the Winner Selection Date. Approximate retail value of all Sweepstakes’ Prizes is \$85,000. Federal, state, or local taxes on the Prize, if any, and any other costs, fees or expenses not listed above are the sole responsibility of the potential Sweepstakes winner.</p>
Taxes	Each winner is solely responsible for reporting and paying any and all applicable taxes related to the Prize. To the extent not provided during the Sweepstakes entry process (set forth above), each winner will be required to provide any requested tax reporting information including a social security number or tax identification number. The US Dollar-equivalent of each Prize exceeds \$600 and therefore requires OANDA, as Sponsor, to provide each winner with an IRS Form 1099 at the end of the calendar year and such Form 1099 will be filed with the IRS. Any winner with any changes to information relevant for filing a Form 1099 must provide such updated information to OANDA before the end of the calendar year.
Winner Selection Method and Odds	OANDA will conduct a random drawing at the conclusion of the Promotion Period among all eligible entries received. The decisions of OANDA are final and binding on all matters relating to this Sweepstakes. Odds of winning depend upon the number of eligible entries received. Selected winners must have both an OANDA FX trading account and an OANDA Crypto account (held by Paxos) in good standing to claim the Prize.
Winner Selection Date	June 21, 2024 at or before 3 p.m. EDT.
Winner Notification Method	<p>The winner will be contacted via email and will have to verify their name, age and address with a government-issued form of identification within seventy-two (72) hours following the time OANDA sends the email notification.</p> <p>The winner will also be announced on OANDA’s website and social media after accepting the Prize. OANDA reserves the right to share the winner’s social media handle publicly at the time of being announced as a winner. Additional details will be provided by OANDA regarding the process of claiming the Prize.</p>
