History

OANDA was co-founded in 1996 by Dr. Michael Stumm, a computer scientist, and Dr. Richard Olsen, an economist, with a vision to leverage the internet to democratise access to currency data. The company initially focused on offering real-time exchange rate information, becoming a source for currency data. In 2001, OANDA launched its foreign exchange trading platform, enabling online forex trading for retail and institutional clients. Over the years, OANDA has expanded its online trading offerings. Depending on geographical location, these include derivatives of global market indices, equities, commodities, treasuries, precious metals, forex, and cryptocurrencies.



Acquisitions

In 2018 OANDA was acquired by CVC Capital Partners, a leading private equity firm. Over time, OANDA made strategic acquisitions of other companies to augment its capabilities, such as Polish multi-asset class broker Dom Maklerski TMS Brokers in 2019 (now called OANDA TMS Brokers) and FCA-registered UK crypto exchange coinpass in 2022 (now called OANDA Coinpass). CVC, via its holding limited partnership CVC Asia Fund IV, entered into an agreement for the sale of OANDA to the FTMO group in January 2025, and the acquisition closed on December 1, 2025, following the securing of required regulatory approvals.
